Debtors 30 days high amount:

Gail qualified actual debtors total \$2,700 of which \$1,000 is over 30 days.

People generally pay on reminder.

Are CSO prices in line with GSO given that a discount is received? Jessica conducted stock review showing some items are selling at a loss. There is to be a review of all pricing.

Brendan (CSC): pointed out that some groups have difficulty making payments (or contributions) due to change of signatories.

Carolyn (Ringwood E Womens): Please clarify the different Donation categories. Jessica advised:

Anonymous Donations - No details of donor (e.g. cash).

Individual Donations - Named donors or beguests.

MCC Donations - Members Contribution Club - Regular contributions by members.

Frank (Berwick Wed): Many people aren't carrying cash - are there other ways to do the 7th tradition?

Innovations (Damian):

Damian outlined the process of setting up a Square account (see appendices).

Matters Arising:

Shaz (Eaglehawk) noted that banks now have apps (for direct payments) which can be accessed by (smart) phone.

Michael (LGBTIQ) noted that Gallery group is trialling payment by scan to QR code linking to group's account.

Noted that there may be further options going forward as technologies develop.

Speakers (especially women) for Windana in St Kilda are needed for the roster (Monday nights) – (please contact CSO to message Robyn).

VPI co-ordinator (Mannie D):

Mannie outlined his role as acting VPI (Victorian Prisons Intergroup) coordinator. Noted that VPI current members may need backup or to rotate off committee and outlined the current status of AA in state institutions – currently in 12 of 18 facilities. Mannie will be seeking a vote at the May 26, 2024 VPI Quarterly Meeting.
